### Healthcare Organizations

Verify Eligibility of facilities

- CTF Staff working to better implement program rules
- Currently, Staff uses CDPH's database to verify license
  - Organizations certified only by federal government (not licensed by CA)
  - Exempt from license with CDPH
  - Licensed by other state agencies (e.g. CDHCS, CDSS)
- Need SME to provide understanding of licensure, certification, and exemptions from license requirements
- Suggestions from Administrative Committee
