This letter is sent in compliance with Ordering Paragraph 9 of D.19-04-021, Entitled "<u>Decision Authorizing Pilot Programs of Boost Mobile, Inc., and iFoster, Inc. in the California LifeLine Program"</u> in R.11-03-013, dated May 3, 2019 ("Decision").

Ordering Paragraph 9 of the Decision reads as follows: "Boost Mobile shall submit an information-only letter to the Communications Division describing the service plans for the pilot within 90 days from the effective date of the Decision and update the information-only letter as its service plans change." (See Decision at p. 54.) Accordingly, Boost Mobile is hereby submitting to the California Public Utilities Commission's Communications Division, this information-only letter that summarizes Boost Mobile's current service plan offers that are available to Boost Mobile pilot program participants.
