GO 156 Report to the Legislature


- Describes utilities progress in procuring from women-, minority-, disabled veteran-, and LGBT-owned business enterprises (WMDVLGBTBEs) based on a 21.5% goal
 - 15 percent (minority-owned), 5 percent (women-owned), and 1.5 percent (disabled veteran-owned)
 - No goal for LGBT-owned
- 31 utilities filed their annual GO 156 report to the CPUC






2016 Utilities Diverse Procurement Overview

2010-2016 Utilities Diverse Procurement Spend and Percentage




2010-2016 Utilities Diverse Subcontracting Spend and Percentage

- Establishment of Community Choice Aggregation (CCA)






Value of Supplier Diversity

Staff conducted a survey of suppliers in the Clearinghouse database in 2016:

- 43.5% were awarded 1-5 utility contracts in 2016
- 69% had utility contract under \$500,000 in 2016




Total Dollar Value of Utility

Employment in 2016: Full Time and Part Time









Value of Supplier Diversity


Subcontract to other diverse businesses

Diverse Businesses in Disadvantaged Communities

- Senate Bill (SB) 350 required the California Energy Commission to complete a study on various topics one of which is on the barriers to contracting opportunities for local small businesses in disadvantaged communities
- Disadvantaged Communities refer to areas throughout California which suffer from a combination of economic, health, and environmental burdens such as poverty, high unemployment, health conditions, pollution, and hazardous wastes (SB 535)
- CPUC assessed utilities diverse supplier data:
 - 27 utilities contracted in total with 2,765 diverse businesses with addresses in California of which 29.04% are located in a disadvantaged community
 - Out of 5,202 California located businesses in the Supplier Clearinghouse database, 30.28% are in a disadvantaged community



Utilities Diverse Suppliers in Disadvantaged Communities








Major Accomplishments

- Implementation of SCH logo policy
- Participated in outreach and training events throughout California
- Implementation of NAICS codes in directory to assist JU sourcing efforts
- Multiple technology enhancements and process improvements implemented
- Extensive reverification outreach
- Increased the number of applications coming into CHS from comparable verification agencies (WBENC, NMSDC, NGLCC)
- Increased Clearinghouse staff
- Provided training to JU members and applicant firms













(CURRENT AS OF 6/30/17)





Additional Information

July 1, 2016 – June 30, 2017

- 2,629 applications processed
- **211** site visits conducted
- 83 denials
- 29 applications protested to the Clearinghouse
- 4 denied applications protested and overturned





GO 156 – Next Steps

Update/Enhance

- Evaluate ways to keep the program successful given new market entrants and dispersed customer dollars; such as get other companies to participate in the program (i.e., CCAs, energy storage, railroads/light rail, etc.)
- Explore the possibility of including other disadvantaged groups
- Identify approaches to best utilize the Utility Subcontracting Program
- Collaborate with utilities to identify and find solutions for challenges and barriers that impacts or may impact the program

Quantify

• Continue to quantify and capture the socioeconomic values of the program to utilities, businesses, communities, etc.

Outreach

- Advocate for WMDVLGBTBEs inclusion in utilities procurement activities
- Increase the number of qualified certified WMDVLGBTBEs
- Strengthen partnerships with WMDVLGBTBEs organizations and communities
