PacifiCorp is currently working to perform both data QA/QC and these inspections are now complete. As part of this review process PacifiCorp has also identified and implemented new processes for additional validation steps to ensure program compliance utilizing the new GIS-based inspections tools moving forward.

³ Three (3) distribution underground inspections were not completed in 2019. In 2019, PacifiCorp rolled out the use of a new GIS-based inspection tool to facilitate more efficient planning and completion of underground inspections. As a result of both first time user errors and process gaps highlighted with this new tool, 3 inspections were missed. PacifiCorp is currently working to perform both data QA/QC and these inspections are now complete. As part of this review process PacifiCorp has also identified and implemented new processes for additional validation steps to ensure program compliance utilizing the new GIS-based inspections tools moving forward.
