Enclosed is Draft Resolution SPD-15. **Draft Resolution SPD-15** establishes the SB-884 program pursuant to Public Utilities Code section 8388.5.

Draft Resolution SPD-15 will be on the agenda at the **January 25, 2024**, Commission meeting. The Commission may then vote on this draft resolution, or it may postpone a vote until a later meeting. When the Commission acts on the draft resolution, it may adopt all or part of it as written, amend or modify it, or set it aside and prepare its own order. Only when the Commission acts does the resolution become binding.

On November 9, 2023, the draft resolution was mailed, pursuant to California Public Utilities Code § 311(g)(1). Comments may be submitted on the draft resolution. Opening comments must be received by December 28, 2023. Reply comments are due 14 days after Opening comments on January 11, 2024.
