



California Water Service Company (Cal Water) General Rate Case – Decision 20-12-007 Visalia District

What does D.20-12-007 Authorize for Cal Water?

Utility Revenue – Company Wide (21 Districts):

- Year 2020: **\$696.5 million (M)**
 - Increase of **\$4.43M** (0.6%) above authorized 2019 revenues
- Estimated Year 2021*: **\$717.4M** and Year 2022*: **\$738.8M**
 - Increase of \$20.9M (3.0%) and \$21.4M (3.0%) respectively

Utility Revenue – Visalia District:

- Year 2020: **\$29.3M**
 - Decrease of **\$0.97M** (-3.2%) above authorized 2019 revenues
- Estimated Year 2021*: **\$30.2M** and Year 2022*: **\$31.3M**
 - Increase of \$0.91M (3.1%) and \$1.02M (3.4%) respectively

Rate Design Changes:

- Tier breakdown of Quantity Rates

Usage (CCF)	Old	New
Tier 1	0-11	0-11
Tier 2	11-29	11-23
Tier 3	29+	23+

- Pipeline replacement
- Water quality treatment and storage improvements

Operation Expense Increases

- Water supply costs
- Customer Support Services
