**SOUTHERN CALIFORNIA EDISON COMPANY'S (U 338-E) FIRST ANNUAL REPORT (FOR
THE PERIOD JANUARY 1 TO DECEMBER 31, 2015) IN COMPLIANCE WITH D.14-03-021**

Southern California Edison Company (SCE) hereby submits its first annual report on the three-year pilot program for conversion of mobilehome parks and manufactured housing communities (collectively, MHPs) from master-meter/submeter service to direct service. SCE's first annual report, attached as Appendix A hereto, provides data for the period January 1 to December 31, 2015. As required by Decision (D.)14-03-021, Ordering Paragraph 10, this annual report includes: (1) a timeline for implementation of the three-year pilot and identifies where the utility is on that timeline; (2) the number of initial applications received; (3) problems experienced with the prioritization process and potential, future solutions; and (4) information about each mobilehome park or manufactured housing community selected for conversion, including the general location (city and county), the number of spaces, whether natural gas or electricity or both will be converted and whether the conversion involves another electric or gas corporation utility or other municipal or public utility provider.

As required by D.14-03-021, Ordering Paragraph 11, this report is verified by an officer of SCE, and is being submitted to the Commission's Executive Director, with copies to each Commissioner, the

Chief Administrative Law Judge, the Director of the Energy Division, the Director of the Safety and Enforcement Division, and all parties listed on the service list for this proceeding.

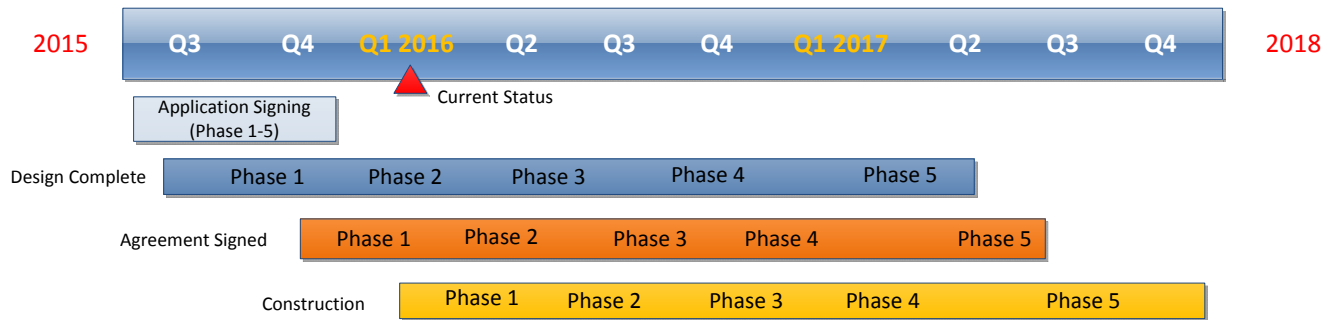
Appendix A

SCE First Annual Report (For the Period January 1 to December 31, 2015)

TIMELINE FOR IMPLEMENTATION OF THE THREE-YEAR PILOT (INCLUDING WHERE SCE IS CURRENTLY ON THAT TIMELINE)

The Program has been designed to complete the transfer of utility service from master-meter/submeter systems to direct utility systems. The program’s goal is to convert approximately 12,457 spaces. In order to better prioritize conversion efforts, the projects have been divided into five phases. The timeline below reflects the proposed stage and timing for each phase.



THE NUMBER OF INITIAL APPLICATIONS RECEIVED

SCE received 803 initial applications.

PROBLEMS EXPERIENCED WITH THE PRIORITIZATION PROCESS AND POTENTIAL, FUTURE SOLUTIONS

SCE did not experience any problems with the initial prioritization process. SCE collaborated with its utility partners to prioritize the list of selected parks into 5 phases. The parks were grouped into phases in order to achieve a viable approach to the conversion of each park. Each park Owner was contacted and invited to a forum to notify them of their phase within the program and to complete the Application.
