Summary: On 08/31/2022 at 14:56 SDG&E was notified by the Fire Department of a large acreage fire. Currently over 4000 acres have burnt. We recently learned that there are multiple SDG&E owned utility poles on this property that sustained fire damages that need to be replaced. The amount of the damages has yet to be determined but will likely exceed the reporting requirement threshold of \$50,000.00. There are no reported injuries. The cause of the fire is not known.
