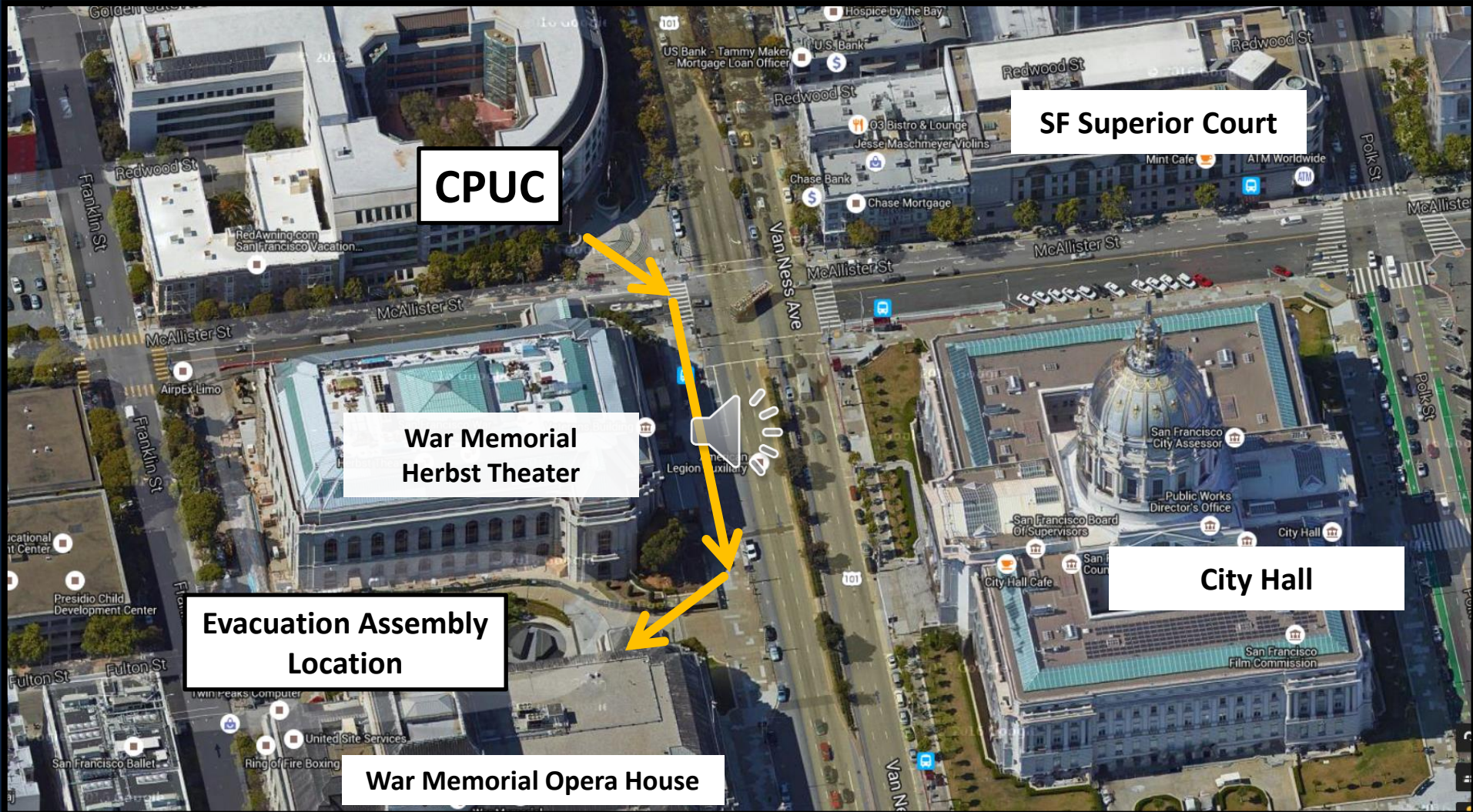

#### **PROPOSED OUTCOME :**

- Approves, as modified in the decision, energy efficiency rolling portfolio business plans of eight program administrators: Pacific Gas and Electric Company, San Diego Gas & Electric Company, Southern California Gas Company, Southern California Edison Company, the Bay Area Regional Energy Network (REN), the Southern California REN, the Tri-County REN, and Marin Clean Energy.
- Sector strategies, metrics, and budgets are approved for 2018-2025. Detailed requirements are set out for the annual budget advice letter filing, due annually every September.
- Implementation plans are required to be posted within 120 days, after the conduct of a stakeholder process.
- Disadvantaged communities and hard-to-reach customers are defined for purposes of energy efficiency programs.
- High level policy guidance is given in the areas of incentive design, integration of demand response and energy efficiency, lighting technologies, and workforce quality.
- Statewide programs and lead program administrators are approved, along with governance and funding process requirements.

#### **SAFETY CONSIDERATIONS :**

- Energy efficiency technologies and activities approved in this decision address safety and quality installation issues in California utility customer facilities.

#### **ESTIMATED COST :**

- Energy efficiency portfolio expenditures are capped at approximately \$900 million annually between 2018 and 2025.

#### **PROPOSED OUTCOME:**

- Adopts Settlement Agreement that amends Rule 18 of General Order 95.
- Adopted amendments reduce the maximum timeframes for utilities to correct specified Priority Level 2 and Priority Level 3 risks to safety or reliability.
- Closes Rulemaking 16-12-001.

#### **SAFETY CONSIDERATIONS:**

- The adopted amendments to Rule 18 enhance worker safety, public safety, and the reliability of overhead utilities facilities.

#### **ESTIMATED COST:**

- Utilities with overhead facilities may incur additional costs, but the amount of such costs is not significant.

- Passenger service on public roads in the State is affected with a public interest, particularly in the areas of passenger safety, driver safety, consumer protection, and the fitness of the companies providing this service to the public.

#### ESTIMATED COST:

- No estimate.
